

BOWEN ISLAND MUNICIPALITY

BYLAW NO. 110, 2004

A Bylaw to amend the "Bowen Island Municipality Public Wharf Services Bylaw No. 59, 2002"

WHEREAS, Council has established regulations for the operation of public wharves maintained by the Bowen Island Municipality through "Bowen Island Municipality Public Wharf Services Bylaw No. 59, 2002";

AND WHEREAS, Council deems it necessary to amend "Bowen Island Municipality Public Wharf Services Bylaw No. 59, 2002";

NOW THEREFORE the Council for the Bowen Island Municipality in open meeting assembled enacts the following:

- 1) This Bylaw may be cited for all purposes as the "Bowen Island Municipality Public Wharf Services Bylaw No. 59, 2002, Amendment Bylaw No. 110, 2004."
- 2) "Section 8. Fines" shall be deleted and replaced with the following:

"8. Fines

Every person who violates any of the provisions of this bylaw, or permits, suffers or allows any act or things to be done in contravention or in violation of any of the provisions of this bylaw, is guilty of an offence and is liable, to a penalty or fine as follows:

| c) further offences in a calendar year | \$150.00 per offence; |

and where the offence is a continuing one, each day the offence continues shall be a separate offence."

- 3) "Section 9. c) Public Conduct" shall be deleted and replaced with the following:
"c) Every person bringing a live animal onto the Wharf or Float is responsible for every animal and must retain control of the animal at all times. The person in charge of the animal is responsible for the immediate removal of any droppings. All dogs are subject to 'Bowen Island Municipality Dog Control Bylaw No. 30, 2001'."
- 4) "Section 1. Definitions" of "Schedule 'A'" to "Bowen Island Municipality Public Wharf Services Bylaw No. 59, 2002" shall be amended for the following definitions:

"day" means 8:00 a.m. to 9:00 p.m.;

"overnight" means 9:00 p.m. to 8:00 a.m., or for the purposes of "Overnight Berthage Fees" means 12:00 noon to 12:00 noon;

- 5) "Table 1" within "Section 2.a) Public Fees, Snug Cove Wharf – South" of "Schedule 'A'" to "Bowen Island Municipality Public Wharf Services Bylaw No. 59, 2002" shall be deleted and replaced with the following:

Table 1 Berthage Fees

Annually

- "Water Taxi" - \$4.50 per foot plus GST and Hydro
- "Emergency Service Vessel" – no charge except for Hydro

Monthly (available October 1st to April 30th only)

- \$4.00 per foot plus GST

Overnight

- \$0.50 per foot including GST

Courtesy Day Use (4 hour maximum, in no case later than 8:00 p.m.)

- under 20 feet - \$2.00 including GST
- over 20 feet - \$5.00 including GST

These fees are waived if the Owner stays on board

Active Loading and Unloading:

- As marked and limited to 15 minutes. There is no charge but the Owner must remain on board.

READ A FIRST TIME this 22nd day of March, 2004.

READ A SECOND TIME this 22nd day of March, 2004.

READ A THIRD TIME this 22nd day of March, 2004.
