

BOWEN ISLAND MUNICIPALITY

BYLAW NO. 229, 2008

A bylaw to replace Eagle Cliff Water System Rates
Bylaw No. 94, 2003 and Amendment Bylaw 185, 2006

WHEREAS the Bowen Island Municipality deems it necessary to increase the annual rates charged, for the Eagle Cliff Water Specified Area.

NOW THEREFORE the Council of the Bowen Island Municipality in an open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited as “Bowen Island Municipality Eagle Cliff Water System Rates Bylaw No. 229, 2008”
2. Bowen Island Municipality Eagle Cliff Water System Rates Bylaw No. 94, 2003, is hereby repealed.
3. Bowen Island Municipality Eagle Cliff Water System Rates Bylaw No. 94, 2003 Amendment Bylaw No. 185, 2006 is hereby repealed.
4. The following annual charges are hereby levied on all properties connected to the water system within the Eagle Cliff Water Local Service Area boundaries:

a. Metered Rates:

The annual charge is based on the average daily consumption for water used as measured by meter, during the period of June to September inclusive, in the previous year:

i. For up to 50 gallons per day	\$390.00
ii. From 51 to 100 gallons per day	\$400.00
iii. From 101 to 150 gallons per day	\$425.00
iv. From 151 to 175 gallons per day	\$460.00
v. From 176 to 200 gallons per day	\$500.00
vi. From 201 to 225 gallons per day	\$540.00
vii. For each additional 1 gallon over 225 gallons	\$ 1.50

- b. The aforesaid charges shall be due and payable no later than one month after the invoice date.
- c. Bowen Island Municipality may reduce any charge fixed in the preceding clause in respect of any premises not occupied throughout any period by an amount commensurate with the period the premises are unoccupied; provided the owner or occupier notifies the Municipality as to the time the premises becomes unoccupied; and that a request is made to the Municipality to have the water supply turned off for the period when the premises are not occupied, subject to the charges levied in section d. of this bylaw.

- d. A charge of \$50.00 will be levied to the owner of the property for which a request of a water turn off or water turn on, is made by the property owner, occupier of the property or the Municipality.
