Eagle Cliff Water System Amendment Bylaw No. 96, 2003

A Bylaw to amend Bylaw No. 79, 2002 establishing the Eagle Cliff Water Supply and Distribution System Specified Area within a portion of Bowen Island Municipality and to establish a Local Advisory Committee

WHEREAS Council has enacted “Bowen Island Municipality Eagle Cliff Water System Specified Area and Local Advisory Committee Establishment Bylaw No. 79, 2002” under the *Local Government Act* to establish the Eagle Cliff Water Supply and Distribution System Specified Area within a portion of Bowen Island Municipality and to establish a Local Advisory Committee;

AND WHEREAS Council wishes to amend Bylaw No. 79, 2002;

THEREFORE the Council of Bowen Island Municipality enacts that the following amendments are made to “Bowen Island Municipality Eagle Cliff Water System Specified Area and Local Advisory Committee Establishment Bylaw No. 79, 2002”:

1. Under “MEMBERSHIP – APPOINTMENT, QUALIFICATION AND TERM OF OFFICE, Section 3 (a) The Committee shall consist of up to five (5) members, each of whom shall be a resident or property owner with the Eagle Cliff Specified Area” is deleted and replaced with “The Committee shall consist of up to six (6) members, each of whom shall be a resident or property owner within the Eagle Cliff Specified Area”.
2. Under “MEMBERSHIP – APPOINTMENT, QUALIFICATION AND TERM OF OFFICE, Section 6 Committee members shall serve without remuneration.” is hereby deleted.
3. Under “HOLDING OF MEETINGS – QUORUM, VOTING AND CONDUCT, Section 7 “The Committee shall elect a chairperson and a vice-chairperson for a one (1) year term at the first meeting held after January 1st. A member of Council shall not be entitled to hold office on the Committee.” is deleted and replaced with “The Committee shall elect a chairperson and a vice-chairperson for a one (1) year term at the first meeting held after January 1st. The non-voting member of Council referred in Section 3(b) shall not be entitled to hold office on the Committee.”

This bylaw may be cited as the “Eagle Cliff Water System Specified Area and Local Advisory Committee Establishment Bylaw No. 79, 2002, Amendment Bylaw No. 96, 2003”.
