**Bowen Island Municipality King Edward Bay Water System
Local Area Service Establishment Bylaw No. 206, 2007**

A bylaw to establish the King Edward Bay Water Supply and Distribution System Local Area Service within a portion of Bowen Island Municipality.

WHEREAS, pursuant to provisions of the *Community Charter*, a Municipal Council may establish a local area service for the provision of a municipal service to certain lands, and to recover costs of providing such service through taxation,

AND WHEREAS the owners of the parcels of land known as the King Edward Bay Estates, described legally as *District Lot 1545, Group 1, New Westminster District, except portions in explanatory Plan 3489 and Plan 13464 (Parcel Identifier 015-940-837)* have petitioned in conformance with Section 212 of the *Community Charter* for the establishment of a local area service for the provision of water supply and distribution services,

NOW THEREFORE, the Municipal Council of Bowen Island Municipality in open meeting assembled, ENACTS AS FOLLOWS:

1. The purpose of the Local Area Service is to provide water supply and distribution for the area to be known as the King Edward Bay Water System Local Area Service, as outlined in Schedule "A" attached to this bylaw, and
2. The method of cost recovery for the service, shall be by user fees, and parcel taxes, as defined by bylaw, to be recovered solely from the properties as defined within the Local Service Area, except that where costs are shared with a neighbouring Municipal Local Area Service then the cost recovery for such items shall be apportioned accordingly and as defined by bylaw.
